An Act to amend the Licensing Acts 1833 to 2008 and to provide for related matters. 5

Be it enacted by the Oireachtas as follows:

PART 1

PRELIMINARY AND GENERAL

Short title, collective citation and construction

1. (1) This Act may be cited as the Intoxicating Liquor (Amendment) Act 2017. 10
- (2) The Licensing Acts 1833 to 2008 and this Act may be cited together as the Licensing Acts 1833 to 2017 and shall be construed together as one.

Interpretation

2. In this Act—
 - “Act of 1927” means the Intoxicating Liquor Act 1927; 15
 - “Act of 1988” means the Intoxicating Liquor Act 1988;
 - “Act of 2000” means the Intoxicating Liquor Act 2000;
 - “Act of 2003” means the Intoxicating Liquor Act 2003;
 - “Act of 2008” means the Intoxicating Liquor Act 2008.

SALE AND CONSUMPTION OF INTOXICATING LIQUOR

Amendment of section 2 of Act of 1927

3. Section 2 (inserted by section 25 of the Act of 1988 and as amended by section 3 of the Act of 2000, section 10 of the Act of 2003 and section 4 of the Act of 2008) of the Act of 1927 is amended— 25

- (a) in subsection (1)(a), by deleting “or Good Friday”,
- (b) in subsection (1)(b)(iii), by deleting “and the eve of Good Friday”, and
- (c) in subsection (1)(b)(vii), by inserting “including Good Friday,” after “any other Friday”.
